

CALL FOR AWARDS



PUPOSE OF THE NEW BUSINESS MODELS AWARDS

The **HORECA NEW BUSINESS MODELS AWARDS** are focused to recognize the work, leadership and transformation of those companies that are committed to innovation in the horeca sector focusing on the areas of business model, new products, equipment, communication management, processes operational, marketing or customer experience.



TOPICS & CATEGORIES

The proposals that will be considered and admitted to participate in these awards must respond to the following topics:

- **Innovation:** innovative products or services in food, equipment, household goods, machinery, technology for restaurants and / or hotels.
- **People, Product, Planet:** companies and professionals with better sensitivity towards the challenge of energy efficiency, sustainability, food waste prevention or the circular economy.
- **Business:** inspiring models of new creation and growth models by national / international expansion.
- **1. DIGITAL HORECA:** digital or technological projects or solutions aimed to improve management, operations, marketing or customer experience in the Hospitality sector.
- 2. **PRODUCT / DISRUPTIVE SERVICE:** products, solutions or disruptive services that offer an improvement in the quality of the service and the final perception of the client.
- **3. DESIGN & EXPERIENCE:** interior design projects which generate a better operational and / or customer experience.
- **4. PEOPLE, PRODUCT, PLANET:** projects related to Corporate Social Responsibility contemplating the improvement of conditions for people, products and the planet.
- INDEPENDENT/ ORGANIZED NATIONAL/ INTERNATIONAL BUSINESS DEVELOPMENT (2 WINNERS): companies that have led a remarkable transformation or growth in their segment.
- **6. NEW BUSINESS MODEL:** new concepts and innovative and disruptive business models for the Horeca sector.
- 7. INNOVATION IN THE HEALTHCARE SECTOR: innovative projects or solutions aimed to improve management, operations, marketing or customer experience in the healthcare sector

EVALUATION CRITERIA

Competing proposals will be evaluated by the **HORECA NEW BUSINESS MODELS AWARDS** Jury in terms of:

- Innovation
- Leadership
- Disruption
- Strategy



EVALUATION PROCESS

PHASE 1

Compliance with the regulations and pre-selection: the organization and the Technical Committee of experts will carry out the first evaluation to verify that each of the candidates meet the technical characteristics and meet the defined selection criteria.

The evaluation process will be carried out by the members of the International Committee of Experts individually, and will serve to choose the finalists of each of the categories.

The finalist candidates will be informed during the week of January 27.

Proposals that exceptionally require it will be required to complement the information.

PHASE 2

Selection of the winners: the International Committee of Experts will meet the days prior to the Hospitality Innovation Planet celebration, evaluate the finalist projects and select the winner of each of the categories.

The finalists will be invited to the **HORECA NEW BUSINESS MODELS AWARDS**, which will take place on **February 25, 2020**, where the winner will be announced in each of the categories.

Any category of the prize could be declared void by the International Committee


