# HOSPITALITY INNOVATION PLANET SHOW 2018 Attendee Registration Terms & Conditions

NEXT BUSINESS EXHIBITIONS S.L. (NEBEXT) welcomes you to Hospitality Innovation Planet Show 2018 (the "event"). NEBEXT and his affiliates or partners provide the event to you, your employees, agents, and contractors, and any other entity or person on whose behalf you accept these terms (collectively "you"), subject to these terms ("terms"). These terms are entered into by and between NEBEXT and you, and you accept them and agree to be bound by them by: (a) signing up for an account on this website; or (b) registering for the event via this website; or (c) accepting an invitation to the event; or (d) consenting to a 3rd party registering you for the event; or (e) by ordering other goods or services via this website; or (f) using the website; or (g) by attending the event.

## **Description of Services**

## Payment

All payments must be made in Euros. Admission to the Event will not be granted without payment in full being received by the applicable due date. NEBEXT's receipt of an application for registration and/or you making payment for registration does not constitute NEBEXT's acceptance of your offer to register for the Event. Applications and payments that are not accepted by NEBEXT will be returned. Whether or not NEBEXT accepts Your application shall be in NEBEXT's sole discretion.

## Cancellations

All sales are final. You will liable for the full cost of Your admission to the Event

notwithstanding a subsequent cancellation or your failure to attend. NO REFUND SHALL BE GIVEN.

You are responsible for cancellation of travel and hotel reservations if You do not attend the Event.

NEBEXT reserves the right to cancel your registration without notice if payment as required by these Terms is not received by NEBEXT in a timely fashion, You fail to provide details as required in the relevant registration form, or You are in violation of any of these or any other applicable terms and conditions. You agree that NEBEXT is not responsible for any damages, direct or indirect, resulting from any cancellations.
